

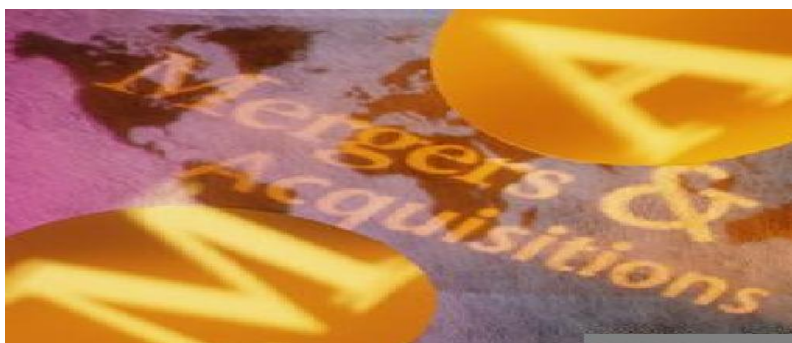
CORPORATE AND SECURITIES

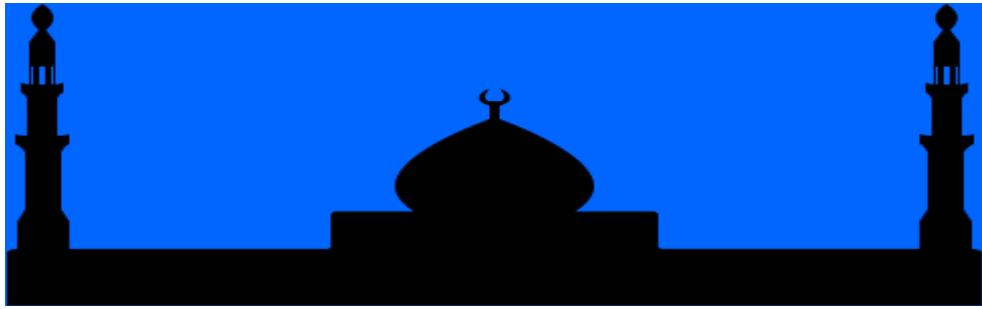

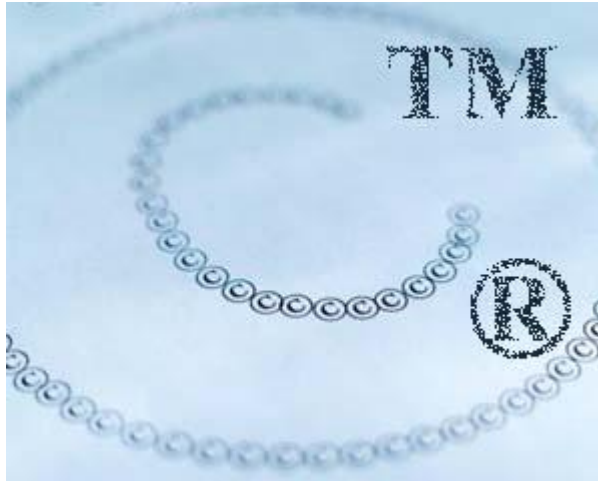

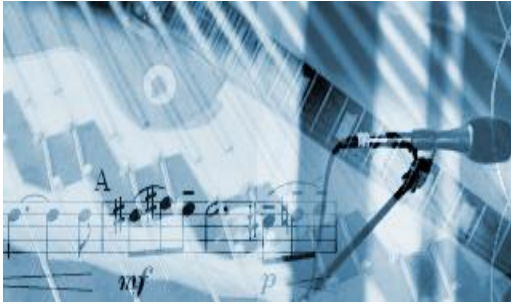

This increases the number of disputes of an inter-state nature outside a unified legal framework and raises issues of the enforceability of standard practices.
